**Essential Qualification:**

- (I) M.S (ENT) or an equivalent degree recognized by the Medical Council of India.
- (II) Five years of experience in postgraduate/Graduate teaching and clinical work in a recognized institution / hospital.

**Desirable:**

Publications in national and international journals

**General Conditions / Information:**
