Leaflet for All India AIISH Entrance examination 2022-23

General instructions for students with application fee details

1. Last Date For the submission of online applications is **15.06.2022, 23.59.59 hours mid night.**
2. Candidates are instructed to go through the Prospectus uploaded in the AIISH website and understand and acquaint themselves:
 - Candidates should apply only 'Online' for B.ASLP / M.Sc. (Aud.)/M.Sc. (SLP) programmes. Candidates who wish to appear for **both M.Sc. (Aud.)/M.Sc. (SLP) Entrance Examination** should apply separately for M.Sc. (Aud.)/M.Sc. (SLP).
 - For Non-entrance based programmes, the hardcopy of the application duly filled and signed should be sent to the Director, AIISH, Manasagangothri, Mysuru-570006 on or before the due date.
 - Prospectus can be downloaded from the AIISH website www.aiishmysore.in.
 - Online submission of Application form may be made by accessing the website www.aiishmysore.in and follow the instructions strictly.
 - Candidates not complying with the instructions shall be summarily disqualified.

4. At the time of online submission of application form, candidate will be required to choose three cities in the order of preference in which he/she wants to take the online test. The choice of city will depend on availability of the test centers in a particular city and the allotment shall be done on first come first serve basis. During the submission of online application form, candidate will be able to see only those cities where slots are available. The final allotment of test centre/venue shall be done by AIISH.

5. Requests for change of testing centre/city shall not be entertained. Candidates are advised not to canvass for the same.
6. Exact address and location of the test centre shall be indicated in the admit card. The specific guidelines to be adhered in the examination center will be displayed in the Institute website.
7. Candidates are required to download their admit card from the website on the specified date announced by the Institute. Admit card will **NOT** be sent to the candidates by Post/email.
8. Candidates **MUST** bring to the test centre the following documents:
 - Printed copy of the Admit Card
 - Any one of the authorized photo IDs (must be original, valid and non-expired)
 - i. PAN Card
 - ii. Driving License
 - iii. Voter ID
 - iv. Passport
 - v. Aadhaar Card (With photograph)/web downloaded Aadhaar copy
 - vi. Student ID card issued by the college
9. The information furnished in the online application form with regard to category remains the same for the purpose of assignment of selection and no change will be entertained in future for any reason. The student should produce the category certificate without fail during the verification of original documents. All claims made in the application must be supported with documentary proof.
10. Candidate must ensure that the mobile number, e-mail address, address entered in the online application form are his/her own.
11. For the latest updates, candidate must keep visiting the AIISH website www.aiishmysore.in till the completion of final round of filling of seats. **All important announcements will be displayed on Institution website and no personal communication through email or SMS will be done.**
12. If any of the information furnished in the online application form is found to be false/incorrect, **the application is liable to be rejected** and the seat allotted to the candidate, if any, is also liable to be cancelled and the entire fee amount paid by such candidate shall be forfeited.
13. If the information furnished by the candidates in the application form or any other document/s submitted by the candidates/parents are found to be false/incorrect/tampered/forged, such candidate's selection will be cancelled at any point of time during his/her course of study and criminal proceedings as per rules will be initiated by the institute against the candidate.

14. The candidates and their parents are strictly advised not to resort to any canvassing, directly or indirectly, to support their applications. Canvassing in any form is strictly prohibited and will be considered as a serious disqualification.

Application fees once paid will not be refunded.

16. Candidates who could not get admission under General Merit quota subsequently, their candidature will be considered under SFS in the order of ranking and reservation.
17. Candidates will be called in the order of their rank in the merit list for personal interview/counselling. Students selected shall be admitted on the same day, on payment of the prescribed admission fees in full, and submit original marks cards for further verification with the University of Mysore. The candidates who have completed their qualifying examination from outside Karnataka have to complete additional formalities at the University of Mysore in connection with Eligibility Certificate/Equivalent Certificate by paying the necessary fees at the University of Mysore on the same day. If a candidate who is called for counselling does not appear by 10 a.m. on the day of counselling or does not get admitted on the same day, the offered seat will be cancelled and the immediate next candidate in the merit list will be offered the seat.
18. Verification of all the original documents will be made at the time of counselling. The candidates should bring the below mentioned documents, as applicable, for counselling. Candidates failing to produce any of the required documents will not be considered for admission. *Two set of photocopies of the relevant documents should also be submitted.*

All Candidates:

- Original marks card of the qualifying examination (PUC/XII Std.)
- Original marks card of 10thstd
- Recent Passport size colour photo – 4 Nos. (in addition to the one on application form)
- Original Degree Certificate and Original marks card of the Degree examination (applicable only for PG programmes)
- Character certificate
- Transfer certificate
- Indemnity bond (*Annexure – III in the prospectus 2022-23*)
- Photocopy of Aadhaar Card

In addition, the candidates belonging to the following categories are to submit the following additional documents:

EWS/SC/ST/OBC Candidates

- Caste certificate/income and assets certificate issued by Competent Authority
- OBC Certificate in the prescribed format (*Annexure-I in the prospectus 2022-23*) for Central Educational Institutions mentioning non-creamy layer status, issued by an appropriate authority. The caste mentioned should be listed in www.ncbc.nic.in as OBC
- Economically Weaker Section (EWS) certificate issued by Competent Authority in the prescribed format for the last financial year (*Annexure-II in the prospectus 2022-23*)

Physically Challenged (Orthopaedics) candidates

- PC certificate issued by competent authority.

North Eastern State candidates

- Domicile certificate/Document in support of having passed XII Std from NE States

Candidates who have completed XII Std/PUC from outside Karnataka

- Eligibility certificate (Formalities to be completed at University of Mysore)
- Foreign Students
 - Foreign passport/Document in support of having passed XII Std from a foreign country; Equivalency certificate (Formalities to be completed at University of Mysore)
 - Necessary clearance from Ministry of External Affairs, Govt. of India in case of applicants holding foreign passport.

19. Such candidates who withdraw from the programme, or cancel their admission for whatsoever reason, and those who are removed from the programme for whatsoever reason, shall forego all payments made by them to the Institute and the University.
20. Information regarding selected candidates and their dates of interview/counselling will be displayed in the Institute's website/Institute's Notice Boards. The candidates are advised to visit the website from time to time. Individual intimation will **NOT** be sent to both selected and non-selected candidates and no further correspondence on this will be entertained.
21. All students (including Post Doctoral Fellows) taking admission to various programmes and receiving stipend/fellowship from the institute are required to submit an indemnity bond on a non-judicial stamp paper of the value of ₹200/- (For contents of the bond please refer www.aiishmysore.in). The bond, duly completed in all respects shall be submitted at the time of admission or within 7 days from the date of admission. However, the admission process will be complete only after submission of the bond. Failure to submit the bond within the stipulated time will result in cancellation of admission.
22. The rules and regulations in this leaflet are subject to change from time to time and the students admitted shall be bound by them.
23. The decision of the Director of the institute shall be final in all matters related to selection of candidates for admission to the various programmes and no appeal shall be entertained on this subject.
24. Before announcement of All India rank list, answer key will be published for filing any discrepancies in the answer key. A maximum of **48** hours time will be given for this purpose. No further representations will be entertained in this regard. The results will be put on website: www.aiishmysore.in along with the answer keys. Candidates selected as per the merit will also be published in the website www.aiishmysore.in. It may be noted that no individual communication would be sent in this regard. List of candidates called for counselling or waitlisted will be notified on our website only. Candidates and parents are advised to browse the website periodically for updated information.
25. Candidates selected for B.ASLP have to be prepared to travel to Mysuru (for admission) at short notice.
26. All matters of dispute shall be limited to High Court of Karnataka.

AIISH B.ASLP (Entrance Examination)

1. The exam shall be conducted on a single day in a single session.
2. The examination will be conducted in four subjects namely, Physics, Chemistry, Biology and Mathematics. All the students **except those applying under the foreign quota**, will have to write the entrance examination in **3 of the 4 subjects**, i.e., **Physics and Chemistry as compulsory subjects and either Biology or Mathematics**, which is based on the CBSE syllabus of 11th and 12th standards.
3. Entrance examination shall be a multiple choice questions and exam will be delivered on computer based platform (CBT).
4. The examination comprises of 150 Multiple Choices, single correct/best Response questions in English language only. Time allotted is 150 min. The question paper shall be divided into 3 parts: Physics, Chemistry and Biology/Mathematics each containing 50 marks.

6. Under no circumstances re-examination will be conducted for those who fail to appear for the entrance examination on the scheduled date and time.
7. A merit list will be prepared based on the total marks obtained from all the three subjects (Physics, Chemistry and Biology/Mathematics).
8. In the event of tie of total score -
 - a. If there is a tie of total score between PCB & PCM candidates, then candidates who appeared for Biology paper of the entrance examination will get preference.
 - b. If there is a tie of total score between PCB candidates, then the relative position of the two candidates will be decided on the marks obtained in Biology followed by Physics and Chemistry.
 - c. If there is a tie of total score between PCM candidates, then the relative position of the two candidates will be decided on the marks obtained in Physics followed by Chemistry and mathematics.
 - d. In case of a tie even after the above conditions, then age of the candidate shall decide the ranking. Students who are older will be placed higher.

AIISH M.Sc. (Audiology)/M.Sc. (Speech Language Pathology)

1. There will be two separate entrance examinations for M.Sc. (Audiology)/ M.Sc. (Speech Language Pathology) courses. Candidates who wish to appear for both M.Sc. (Aud.)/ M.Sc. (SLP) entrance examination should apply separately for M.Sc. (Aud.)/ M.Sc. (SLP), respectively.
2. Both the exams shall be conducted on a single day.
3. The syllabus shall comprise of subjects/knowledge assessed as per the B.ASLP course issued by Rehabilitation Council of India. Kindly refer to the RCI website <http://www.rehabcouncil.nic.in/.org> for complete document.
4. Entrance examination shall be a multiple choice questions and exam will be delivered on computer based platform.
5. The examination comprises of 100 Multiple Choices, single correct/best Response questions in English language only. Time allotted is 100 min. The question paper shall be divided into 3 parts (Part A, B and C) each containing 20, 10 and 70 MCQs respectively. The distribution of MCQs in these parts shall be as per Para 8.
6. There shall be 25% negative marking for incorrect answers. No marks will be deducted for unattempted questions.
