#### (vii) Frequently Asked Questions (FAQs)

##### 1.Qn :: Can you highlight the role for Speech and Language Pathologist?

**Ans:** Speech and Language Pathologist plays an important role in identifying and rehabilitating different types of speech and language disorders, such as delay in acquisition of speech, errors in pronunciation, difficulty in maintaining fluency in speech, voice problems (such as hoarseness, breathiness), loss of speech after stroke, swallowing problems and poor scholastic performance.

##### 2.Qn :: What are the common causes of delay in speech and language acquisition?

**Ans:** The few common causes for delay in speech and language acquisition include,

- Not responding to sound in the vicinity.
- Lack of speech and language stimulation
- Poor mental abilities.
- Poor socialization skills.
- Poor motor skills/oro motor abilities.
- Over pampering of the child at home and increased adamant behaviors of the child.
- Poor attention skills, hyperactivity and behavioral issues.
- Exposure to multiple languages.

##### 3.Qn :: List of disorders treated at AIISH

**Ans:** All communication disorders such as delay in speech & language skills, hearing impairment, intellectual disability, autism spectrum disorders, attention deficit hyperactive disorder, learning disabilities, voice problems, stammering/stuttering, mispronunciation, cleft of

the lip and palate, removal/surgery of voice box, cerebral palsy, loss of speech & language after stroke/ accidents and swallowing disorders are treated at AIISH.

**4.Qn :: Are there ways of identifying delay in speech and language acquisition?**

**Ans:** Yes, Speech-Language: Speech and language acquisition follows a normal developmental pattern as given,

- By the age of 3-6 months, babies produce strings of sounds (Eg. bababa-papapa-tatata)
- By the age of 9-12 months, the child will be able to produce a few meaningful words (Eg. Amma, Appa)
- By the age of 18-24 months, the child will be able to use simple phrases (Eg. Mummy water, daddy bye)

If there is any delay in the acquisition of the milestones as mentioned above or if you detect any above listed common causes, consult Speech and Language Pathologist immediately.

**5.Qn :: Can you specify the normal developmental stages of motor activities in children?**

**Ans:** The normal motor milestone acquisition pattern is as follows,

- Neck control: 3-4 months
- Turning over: 4-6 months
- Sitting: 7-8 months
- Crawling: 8-9 months
- Standing: 9-10 months
- Walking: 10-12 months

If there is any delay observed, immediately consult Paediatrician/ Physiotherapist/ Psychologist/ Speech and Language Pathologist for further guidance.

**6.Qn :: My child is 3 years old and has not started speaking yet and my family members have advised that he will pick up normal speech and language skills at a later age. Should I wait for a few more years?**

**Ans:** The answer is definitely, NO. An immediate evaluation has to be taken up without any delay. Maximal development of speech and language skills occurs within first 4 years of life. During this period, intensive speech and language stimulation must be carried out, which the child would be benefitted maximally. Hence there should be no delay in consultation.

**7.Qn :: My 2 years old child is aged is not able to utter speech sounds such as 'ra', 'sa', 'sha' 'skra' and his speech is unclear compared to his peer group. What actions should I take?**

**Ans:** There is a normal pattern in acquisition of different speech sounds, the sounds mentioned above would be acquired around 3.5-4 years normally. In exceptional cases, few children acquire it at early ages. Do not pressurize the child or do not keep comparing with the peer group. Consult Speech and Language Pathologist at the earliest.

**8.Qn :: Are there any medications to resolve my child's speech and language problems or improve mental abilities?**

**Ans:** So far there are no particular medications which rectify speech and language problems or improve mental abilities. But speech problems can be set right/ improved by attending speech therapy, which is also dependent on cause and severity of the problem.

**9.Qn :: After operation of tongue tie, will my child talk clearly?**

**Ans:** Even after tongue tie is released, the child must attend speech therapy sessions to rectify the wrong articulatory patterns the child has learnt already.

**10.Qn :: Once we put the hearing aid, will my child start talking?**

**Ans:** Hearing aid is no magic. It just amplifies the sound. Since the child has no exposure to listening to sounds from birth, special training should be given to enhance listening speech and language skills.

**11.Qn :: Can I place my child in normal school in spite of having speech and language problems?**

**Ans:** The child can be placed in normal school parallelly rectifying speech and language problems under the guidance of a speech and language pathologist. The child requires special attention by the parents, teachers and other professionals.

**12.Qn :: My child is more than 15 years old with poor mental abilities. What can I do for him/her now?**

**Ans:** Try taking help of Speech-Language Pathologist to teach language skills for the child, you can also enroll the child to vocational training institute. The child can learn few vocational skills to support himself/herself without depending on anyone. Vocational skill includes candle making, simple hand jobs etc.

**13.Qn :: My child is not socializing with other children and prefers to be aloof. I referred to the internet and features are matching with diagnosis of Autism. Is my child autistic?**

**Ans:** From the description the child seems to have autism. However, the diagnosis can be confirmed only after detailed evaluations. Kindly consult Speech Language Pathologist at the earliest. Early identification and rehabilitation is the key for better communication skills.

**14.Qn :: When my child attempts to stand/sit/pick up any objects he becomes stiff and is not able to communicate like other children of his age. Is such a condition treated at your institute?**

**Ans:** Yes, you can bring your child for detailed evaluations for issues with mobility, Speech-Language skills and mental abilities. Based on the deficits, identified guidelines on further management will be provided.

**15.Qn :: From birth my child is having cleft (hole) in the lip and palate. When he speaks, it sounds as if he is speaking through nose and when he drinks/ eats food comes out through nose. What can be done for the same?**

**Ans:** Cleft in the lip and palate can be repaired by a plastic surgeon and speech clarity can be improved through speech therapy. Consult Speech and Language Pathologist immediately without any further delay.

**16.Qn :: My child is excellent in all the activities except in reading and writing and does not show interest towards academic activities. Could you please suggest on this?**

**Ans:** From the description the child seems to have learning disability. However, the diagnosis can be confirmed from our specialized facilities to evaluate and manage the condition.

**17.Qn :: Provide the details on working days and timings of AIISH**

**Ans:** Working days: Monday to Friday

Working hours: 9.00 am to 5.30pm

Institute remains closed on all central government holidays.

**18.Qn :: Who are the consultants available at AIISH?**

**Ans:** Speech-Language Pathologists, Audiologists, ENT Specialists, Clinical Psychologists, Physiotherapists and Occupational therapists on a regular basis and Paediatrician, Dietician,

Plastic surgeon, Phonosurgeon and Orthodontist are available weekly once/ twice. However, only clients with speech, language and hearing disorders will be registered.

**19.Qn :: What are the accommodation facilities available for patients from other places?**

**Ans:** Kuteeras are available with minimum facilities for patients from other places. Rooms will be allotted for maximum of 15 days and can be booked through DD/cash but only after registration process. Allotment is subject to availability. Catering facilities are not available.

**20.Qn :: What are the certificates/ forms issued from AIISH?**

**Ans:** Certificates for Hearing Impairment, Learning Disability and other forms like School Admission, Therapy Attendance, Language Exemption (Where Applicable) and Preferential Transfer are issued.

**21.Qn :: What is the duration of treatment in AIISH?**

**Ans:** We provide either **Demonstration therapy** which can be of,10 or 15 sessions or **Regular Therapy** which would continue for 2/3 months (weekly 2/3 sessions)

**22.Qn :: Are prior appointments available for therapy?**

**Ans:** No, as the therapy can be provided only after detailed speech-language evaluation.

**23.Qn :: When can I start the treatment for my child?**

**Ans:** Bring the child for treatment as early as possible. As soon as the evaluation is complete, treatment can be initiated. The earlier it is identified, better is the progress.

**24.Qn :: Will my child become normal after treatment?**

**Ans:** We treat children with the goal of strengthening the residual abilities and minimising the limitations of the child. Few children, especially those with lesser severity of problem, tend to catch up with their peers and improve a lot, provided the parents provide good home training. Others have to undergo continuous and intense home stimulation for communicating their basic needs.

**25.Qn :: How much should I pay for treatment?**

**Ans:**

Registration charges	₹ 50/-

**26.Qn :: What are the different types of therapies available at AIISH?**

**Ans:** Speech-language therapy, listening training for children with hearing impairment, physiotherapy, occupational therapy, reading and writing remediation program for persons with learning disability and dysphagia treatment.

**27.Qn :: What is the registration process?**

**Ans:** Persons with communication disorders (only speech-language and hearing disorders) have to register at registration counter (Room No. 1) in the Department of Clinical Services, All India Institute of Speech and Hearing (AIISH) upon arrival. After registration, necessary evaluations will be carried out with appropriate referrals/recommendations.

**30.Qn :: How can I submit a work order request?**

**31.Qn :: Are the forms available in e-mode?**

**Ans:** As of now, only physical formats are available in the website. E-formats will be available in coming days.

**32.Qn :: What should I do for an urgent work request?**

**Ans:** First come, first serve is our policy. We do follow a priority system for work requests. If any work needs to be done very urgently, request through proper channel will facilitate completion of the work on priority. Depending on the nature, time and other responsibilities priority will be given.

**33.Qn :: Are separate work order formats available for each service? Or we have to indent in the single format for all services?**

**Ans:** Exclusive work order formats are available for each work.

**34.Qn :: Whom should I contact after indenting the work ? And what is the extension number?**

**Ans:** After indenting the work, you should contact the concerned staff. For reg: If you have requested for designing work, you can contact the Graphic Designer in the Department directly. 0821-2502156/166 are the extension numbers to contact the staff of the Department.

**35.Qn :: How to become a member of the Library and Information Centre (L&IC), AIISH?**

**Ans:** We provide two types of memberships, regular membership for the staff and students of AIISH and temporary membership for those working /studying in other organizations.

**36.Qn :: How to become a member of the Library and Information Centre (L&IC), AIISH?**

**Ans:** We provide two types of memberships, regular membership for the staff and students of AIISH and temporary membership for those working /studying in other organizations.

**37.Qn :: What are the procedures to take a Regular Membership?**

**Ans:** The eligible persons have to submit an application in prescribed form made available on the web portal of the L&IC at <https://www.aiish.ac.in/> ( Online Application Forms)

**38.Qn :: Can the application form for regular membership be submitted directly?**

**Ans:** In the case of Diploma/UG/PG students, the filled-in forms can be submitted directly to the L&IC. In the case of staff and research scholars, the recommendation has to be obtained from the respective heads of department/section/unit.

**39.Qn :: Are the contract staffs at AIISH eligible for regular membership?**

**Ans:** Yes, They have to remit a caution deposit of ₹4000/- in the Institute account, and this has to be duly certified by the Accounts Officer in the application form.

**40.Qn :: What is the validity of a regular membership?**

**Ans:** The regular membership is valid till the end of the course, in the case of students, expiry of the contract term in case of contract staff, and service retirement in case of permanent staff.

**41.Qn :: Who are eligible for Temporary Membership?**

**Ans:** The students, faculty and professional in other organizations.

**42.Qn :: What are the procedures for taking temporary membership?**

**Ans:** The eligible persons have to submit an application in prescribed form made available on the web portal of the Section at <http://www.aiish.ac.in/> and student for the approval of the Director, AIISH. Also, they have to attach a scanned copy of the organization ID card.

**43.Qn :: Is there any usage fee for availing L&IC facilities and services?**

**Ans:** The facilities and services are free for regular members. However, temporary members have to make a prescribed fee in the Institute account as given below for availing of the facilities.

**44.Qn :: Will all the users be issued a library card?**

**Ans:** The card will be issued to the regular members and temporary members with a membership duration of 6 months.



**45.Qn :: Is there a provision for issuing duplicate library card in case the original is lost?**

**Ans:** Yes. The duplicate card will be issued upon paying a fine of ₹ 200/- at the Institute's cash section and producing the receipt to the L&IC

**46.Qn :: Should I carry the library card during every visit to the Section?**

**Ans:** Yes. Without a library card, you will not be permitted to enter the Section.

**47.Qn :: What is automatic gate entry?**

**Ans:** The automatic gate register is the barcode enabled computer system for recording the entry and exit of the users. It is installed at the entrance of L&IC. All the users must record their entry and exit using their barcoded card at the barcode scanner made available at the counter.

**48.Qn :: Do all the members are eligible for borrowing books from the L&IC?**

**Ans:** No. Only the regular members are eligible for borrowing books. The temporary members are entitled to use the L&IC for reference purpose only and will issue no books.

**49.Qn :: Will there be any fine for delayed return of borrowed books?**

**Ans:** Yes. Fine will be collected from all the defaulters. The details of fine levied are given below.

**50.Qn :: What are the procedures for borrowing books?**

**Ans:** The books are issued upon processing the library card. The card will be scanned against the borrower database and book will be issued as per the eligibility of the individual user.

**53.Qn :: How can I recommend a new resource (books/journals, etc.) to purchase/subscribe for the library?**

**Ans:** An authorized user can recommend a resource to procure by filling the 'Resource Suggestion Form' available on the library web portal <http://www.aiish.ac.in> ( Online Application Forms).

**54.Qn :: Can the bring personal patrons books or other reading materials to the library?**

**Ans:** No.The patrons are not allowed to bring their own books or other reading materials to the library.

**55.Qn :: Does the library have a WiFi connection?**

**Ans:** Yes. It is available.

**56.Qn :: If a borrowed book is lost or damaged should be replaced?**

**Ans:** Yes. The lost or damaged book has to be replaced or equal to double the cost of the book needs to be paid as fine.

**57.Qn :: Do patrons give training on how to access and use resources?**

**Ans:** Yes, The L&IC organizes the 'workshop on electronic resources' at the beginning of the academic year having both theoretical and practical components.

**62.Qn :: What is back volume, explain its access mode?**

**Ans:** The bound volume as the bound issues of the scientific journals subscribed by the L&IC.

They are arranged alphabetical by title of the journal is chronological order.

**63.Qn :: What are the various e-resources available in the L&IC?**

**Ans:** The various e-resources accessible on the web portal of the L&IC are the following:

- AIISH digital repository: A repository of AIISH research reports
- E-Journals: AIISH subscribed / Free/ERMED/N-LIST e-journals.
- E-Books: AIISH purchased/ N-LIST e-books.
- Online Databases: AIISH subscribed / free databases.
- Digitized question papers: University Question papers of the academic programs conducted by AIISH.
- Digitized syllabus: University syllabus of the academic programs conducted by AIISH.
- CD-ROM resources: Contents of the CD-ROMs received along with the books purchased.

**64.Qn :: What types of e-books are available and what is their access mode?**

**Ans:** The two types of e-books are AIISH subscribed e-books, and N-LIST e-books. Users may download or read the e-book through the e-book searching link. The AIISH subscribed e-books are accessible only using the computer connected to the institute from inside the campus. The N-LIST e-books are accessible for nay where using user name and password.

**65.Qn :: What type of e-journals is available and how to access them?**

**Ans:** The types of e-journals are: (i) AIISH subscribed (ii) ERMED (iii) N-LIST e- journals. Of these AIISH subscribed and ERMED e-journals are accessible only for inside the campus. The face e-journals located on the portal are accessible for anywhere. The N-LIST e-journals are accessible using user name and password.

**66.Qn :: What are the database available, and how to access them?**

**Ans:** We offer bibliographic, full-text and hybrid databases. (i) ComDisDome and Linguistics and Language Behavior Abstracts (LLBA), (ii) J-Gate (iii) SCOPUS (iv) IEEE Explore (v) MedOne ComSci (vi) PubMed (vii) Rehabdata

**67.Qn :: Which type of format Standards are available and how to access them?**

**68.Qn :: Some of the library books have supplementary material in the form of CD-ROMs. But we never get issued CD-ROMs along with books, Why?**

**Ans:** Since the CD-ROMs are very fragile in nature, we are not issuing them along with the books. However, the contents of book CD-ROMs are available for downloading for our web portal makes the link 'Book CD-ROMs'.

**69.Qn :: Can I access the previous volumes of journals online?**

**Ans:** The previous volumes of a journal are called back volumes or journal archives. We have online back volumes of the thirty-five most important international journals on the field of speech and hearing.

**70.Qn :: What are the various services available in the L&IC, and how can we use them?**

**Ans:** The various services provided on the web portal of the L&IC are the following:

- Personalized Information Service: Service from outside the campus
- Plagiarism Detection Service

- OPAC
- NLIST Service
- Writing Support Service (Grammarly): Service detecting writing grammar errors in research papers/reports/letters etc.
- Typeset Author Solution: Service which facilitates help to write and submit research papers for journals.
- ISBN Service: Service facilitates assigning the ISBN to AIISH publications coordination with Raja Rammohun Roy National Agency for ISBN, Ministry of Education, Govt. of India.
- Bibliographic Management.

**71.Qn :: What is OPAC, and how to use it?**

**Ans:** OPAC stands for Online Public Access Catalogue. It is a tool to search and locate resources in the L&IC. The OPAC facilitates author, title, keyword, year and subject based searching.

**72.Qn :: What is personalized information service and how to avail it?**

**Ans:** Remote access service facilitates access to subscribed resources from outside the campus. The details of available the service is provided under 'Personalized Information Service' on the web portal.

**73.Qn :: Explain the procedure for accessing the digital repository?**

**Ans:** The users have to register for availing the services under the link 'Digital Repository'. Upon registration, they can access the reports of all types of research carried out at AIISH including post-graduate, doctoral and funded research.

**74.Qn :: What is N-LIST e-resource service?**

**Ans:** The NLIST stands for National Library and Information Services Infrastructure for Scholarly Content. Using this service the user can access e- journals, e-books, and databases of different disciplines. The service is user name and password based. The members have to contact the L&IC for generation of user name and password. **75.Qn :: What is ERMED?**

**Ans:** ERMED stands for Educational Resources in Medicine. It is sponsored by Ministry of Health & Family Welfare, Govt. of India. Through the service, we have are getting access to 240 e-journals in different medical subjects.

**76.Qn :: What is an anti-plagiarism service, who are eligible, and how to access?**

**Ans:** Anti-plagiarism service is based on Turnitin, a web-based originality checking software. This service helps determine the originality in research papers and reports prepared by the institute staff and students by cross-checking the documents against the already published articles available online. It is based on username and password and restricted to the regular members. The members have to submit an application from (available in web portal) duly approved by the Director.

**77.Qn :: What is ISBN, and how to apply?**

**Ans:** International Standard Book Number (ISBN) is a 13 digit numeric code that serves as a unique identifier for books. This number captures information regarding the book publisher, title, language, edition, and version. The faculty and staff of AIISH responsible for preparing the materials can apply in the prescribed format available in the library web portal and obtain ISBN before sending the material for printing.

**78.Qn :: What is a writing support service, who is eligible, and how to access?**

**Ans:** Writing support service is based on Grammarly software. This software detects grammatical errors in research papers/reports/letters etc. This is a username and password based service available only for the regular members. The username and password are being generated by the L&IC staff upon receiving request from the regular members. The service is accessed anywhere using username and password.

**79.Qn :: What is the author's solution, who is eligible, and how to access?**

**Ans:** Author solution service based on Typeset software. This software facilitates writing and submitting a formatted research paper for journals. This is a username and password based service available only for the regular members. The username and password are being generated by LIC staff upon request from the regular members. The members may access anywhere using username and password.

**80.Qn :: Is Panchavati campus a part of Campus Network/Intranet?**

**Ans:** Yes. All the computers connected to the Internet from the Panchavati campus are part of Intranet.

**81.Qn :: What is the difference between Speech-Language Pathology and Speech-Language Sciences?**

**Ans:** The term speech-language pathology refers to disorders of speech and language while 'sciences' refers to the typical process of communication and is not related to 'disorders'.

**82.Qn :: How is the speech-language pathology department different from other departments of AIISH?**

**Ans:** The department of speech-language pathology is the core department from which other services (now independent departments) emerged. The research and clinical activities of the department focuses on effective rehabilitation of persons with speech, language and swallowing disorders.

**83.Qn :: How can one avail services of this department?**

**Ans:** Please contact the office (0821-2502261) or the head, department of speech-language pathology for procedures to avail services of the department.

**98.Qn :: Can my child with hearing impairment avail services?**

**Ans :** Yes. Kindly ensure that a recent audiological evaluation is done and the child is using appropriate amplification devices.

**99.Qn :: Does TCPD offer services to adults and older individuals?**

**Ans :** Yes, we provide services to individuals with any communication disorder, across all age ranges.

**100.Qn :: How early can hearing loss be identified in a child?**

**Ans :** Hearing loss can be screened as early as the neo-natal stage. Responses to sounds around can be checked both through instruments and without instruments. Thus, hearing loss can be identified and rehabilitation can be started as soon as the child is born. Better prognosis is expected with the early identification and intervention.

**101.Qn :: How do I know if my child is a late talker?**

**Ans :** Does your child understand and speak similar to his/her age-matched peers? If you feel that he/she may not be doing so, kindly get your child screened/evaluated for communication disorders.

**102.Qn :: My child seems to be a late talker, does he need speech and language therapy?**

**Ans :** Yes, better prognosis is expected with the early identification and intervention.

**103.Qn :: My father had a stroke, will his speech return with tele-intervention?**

**Ans :** Yes, recovery is expected with tele-intervention. However, the speed and extent of recovery is determined by a number of internal and external factors.

**104.Qn :: Do children with special needs always have disabilities?**

**Ans :** Not necessarily. Even gifted children and children with special talents may at times face difficulties in academic learning, and need special support. However, in most instances it happens to be that children with impairments in sensory, motor, cognitive and/or socio-emotional and behavioural functioning are in need of intensive support.
