Admissions to all the Ph.D. Programs will be done based on the performance in the Written Test and Interview. The eligible candidates are informed to submit the duly filled-in applications through Post/by hand to *The Director, All India Institute of Speech and Hearing, Manasagangothri, Mysuru – 570 006.*

- > There will be separate entrance examination for Ph.D. in Audiology, Speech Language Pathology and Special Education.
- The syllabus shall comprise of subjects/knowledge assessed as per M.Sc (Audiology)/M.Sc (Speech Language Pathology)/ M.Ed.Spl.Ed (HI) course issued by Rehabilitation Council of India. Kindly refer to the RCI website http://www.rehabcouncil.nic.in/.org for complete document.
- The question paper consists of 50 MCQs, single correct/best Response questions and 50 marks descriptive type questions. Total duration of the examination is 02:30 hours.
- A candidate is required to secure a minimum of 55 marks out of 100 in the entrance test to become eligible for Ph.D. provisional registration. However, this requirement is relaxed to 50

marks out of 100 for OBC/ Non creamy layer/Transgender candidates and 45 marks out of 100 in case of SC/ST.

General instructions for candidates:

- 1. Candidates are instructed to go through the Prospectus uploaded in the AIISH website and understand and acquaint themselves.
- 2. Candidates should send the hardcopy of application duly filled and signed to the Director, AIISH, Manasagangothri, Mysuru-570006.
- 3. Candidates should carry the Admit card, Ball point pen of good quality and Aadhaar / driving license / any other document for proof of Identity, to the Examination Centre.
- 4. The candidate must retain a photocopy of his/her application form and UTR number of payment for future correspondence and for availing duplicate hall ticket, if required.
- 5. Under no circumstances re-examination will be conducted for those who fail to appear for the entrance examination on the scheduled date and time.
- 6. Answers are to be shaded using **BLACK BALL POINT PEN** only
- 7. There is no negative marking for wrong answers.
- 8. If more than one answer is indicated against a question, no marks will be awarded for the same.
- 9. Any form of overwriting and erasing on the answer sheets will be processed by the computer as an incorrect answer.
- 10. There is no provision of revaluation of answer sheets.
- 11. In the event of tie, older candidate will be placed at a higher merit position.
- 12. Candidates called for entrance examination/interview have to make their own arrangements for their stay. No TA/DA is admissible for this purpose.
- 13. Before announcement of All India rank list, answer key will be published in the website for claiming any discrepancies in the answer key. A maximum of 24 hours time will be given for any such claim. No further representations will be entertained in this regard. The results/merit list will be put on our website: <u>www.aiishmysore.in</u> along with the answer keys.

- 14. Candidates who qualified in the entrance examination will be called for personal interview. List of candidates provisionally selected for the Ph.D. (Audiology / Speech Language Pathology/ Special Education) will be updated in the website.
- 15. Verification of all the original documents will be made at the time of admission.
- 16. The decision of the Director of the institute shall be final in all matters related to selection of candidates for admission to the various programmes and no appeal shall be entertained on this subject.
- 17. Any other details not listed here will be as per the University of Mysore Ph.D. Regulations.
